1. None appears on behalf of the petitioner at the time of call.
2. Learned advocate for the alleged Contemnor No.2 is, however, present.
3. At the time of hearing it is submitted on behalf of the alleged Contemnor No.2 that pursuant to the judgment and order dated 4th April, 2025, as passed by this Court in WPA 16213 of 2025 as well as in view of the earlier order dated 2nd April, 2026, as passed in the instant contempt petition, the alleged Contemnor No.2 proceeded for reconstruction of the boundary wall. However, the alleged Contemnor No.2 has been prevented by the writ petitioner for which the writ petitioner lodged complaint in writing on 5th May, 2026, with the jurisdictional BDO, the Officer-in-Charge

of Ramnagar Police Station and the Executive Engineer, WBSRDA, Panchayat and Rural Development department.

4. It is submitted on behalf of the alleged Contemnor No.2 that unless a Special Officer is appointed at the cost of the alleged Contemnor No.2, the alleged Contemnor No.2 apprehends that he will not be in a position to comply with the order of this Court.
5. Such being the position, liberty is given to the alleged Contemnor No.2 to file copies of the aforementioned written complaints dated 5th May, 2026, with the aforementioned three various authorities by way of supplementary affidavit on the adjourned day after serving advance copy of the same to the learned advocate for the petitioner.
6. On the adjourned day this Court shall consider the prayer of the alleged Contemnor No.2 for appointment of Special Officer at the cost of the alleged Contemnor No.2.
7. Let this matter be listed on May 15, 2026, under the same heading, preferably retaining its same position.
8. Since none appears on behalf of the writ petitioner today, the learned advocate-on-record for the alleged Contemnor No.2 is hereby

requested to forward a server copy of today's order to the learned advocate for the writ petitioner by a covering letter and to file receipt thereof on the adjourned day.
