1. The revisional application has been preferred by the wife/petitioner praying for transfer of Matrimonial Suit no. 132 of 2025/132(07/2025 from the Court of the learned Additional District Judge, Fast Track Court, Siliguri, District - Darjeeling to the Court of the learned 1st Additional District Judge, Baruipur, District- South 24 Parganas.

2. It is the case of the petitioner/wife that she is residing at Ramesh Majumder Sarani, Deshbandhupara, Near Dadabhai Club, Ward No. 29 of S.M.C., P. O. & P. S. Siliguri, District - Darjeeling, PIN 734004 with her minor child of 2 years.

3. On the other hand the husband/opposite party is a resident of Pramila Apartment, M. M. Dutta Road Bye Lane, Deshbandhupara, Near Bow Bazar, Ward No. 30 of S. M. C., P. O. & P. S. Siligiri, District – Darjeeling, PIN 734004.

4. The petitioner/wife now prays that the suit being Matrimonial Suit No. 132 of 2025/132(07/2025 pending in the Court of the learned Additional District Judge, Fast Track Court, Siliguri, District - Darjeeling be transferred to the Court of the learned 1st Additional District Judge, Baruipur, District- South 24 Parganas.

5. Accordingly, in view of the judgment of the Hon'ble Supreme Court in ***N.C.V. Aishwarya vs A.S. Saravana Karthik Sha, in Civil Appeal No(s). 4894 of 2022 (arising out of SLP (C) No(s). 16465 of 2021), decided on July 18, 2022, (Para 11, 12)***, the revisional application is required to be heard in presence of the opposite party.

6. Petitioner is directed to serve upon the opposite party and file affidavit of service on the next date of hearing.

7. Pending hearing of the revisional application under Section 24 of the Civil Procedure Code, the proceedings in Matrimonial Suit No. 132 of 2025/132(07/2025 pending before the Court of

the learned Additional District Judge, Fast Track Court, Siliguri, District - Darjeeling be stayed till 31st August, 2026 or until further order, whichever is earlier.

8. Matter to appear on 20th of August 2026 for further hearing.

9. Matter be placed before the next Circuit Bench.

10. Department is directed to send the records to the Jalpaiguri Circuit Bench.
