The Court:-

In Re: GA/191/2024

The Report of the Joint Administrators dated 4.12.2025 be kept on record.

GA/191/2024 has been filed with various prayers. One of the prayers submitted by Mr. Ghosh, learned Senior Counsel appearing for the Joint Administrators is that specified seven flats, particulars of which are in the Report of the Joint Administrators, are lying vacant, possession of which should be taken by the Joint Administrators pursuant to the Order dated 12.8.1983 passed by Justice Majula Bose.

Mr. Deb, learned Senior Counsel appearing for the CIC Society confirmed that the seven flats are vacant and the Society has no objection if the possession be taken by the Joint Administrators.

Mr. Ghosh, learned Senior Counsel for the Joint Administrators submitted that a paper publication was made in the year 2024 pursuant to the direction of this Court and seeks to file supplementary affidavit to produce those paper publications.

Let the supplementary affidavit be filed on or before the returnable date. In the meantime, a further notice of taking possession shall be pasted in the outer part of the said flats by the Joint Administrators before passing any further order.

Let the matter appear in the list on 19th December, 2025.
