The Court:- Affidavit-in-reply filed by Ms. Agarwal in GA No. 1 of 2024 as well as affidavit-in-opposition in pending applications be kept in the record. Affidavit of service filed in GA No. 6 of 2025 be kept in the record.

Exchange of affidavits is not complete so far as GA No. 1 of 2024 is concerned. GA No. 1 of 2024 is an application for ad interim order of injunction.

Affidavit-in-opposition shall be filed within two weeks from date; affidavit-in-reply, if any, within one week thereafter. No further time shall be allowed to exchange affidavits.

So far as other pending applications are concerned, namely GA No. 2 of 2024, GA No. 3 of 2024, GA No. 4 of 2024, GA No. 5 of 2024 and GA No. 6 of 2025 – all being demurrer applications, the same shall be taken up before hearing of injunction application.

Let these matters appear in the list on 8th May, 2025. Injunction application in GA No. 1 of 2024 shall also appear in the list on that date for passing further order.
