The Court:- Learned Advocates for the parties are present.

It is submitted by the learned Advocate for the decree-holder that the judgment-debtor till today has paid Rs.10,29,000/- although the amount due and payable with regard to the principal sum excluding interest was Rs.26,54,355.74/-.

Learned Advocates also submits that the bank accounts of the judgment-debtor be attached and the bank authorities be directed to furnish a Report as to the amounts lying in the accounts. In the facts and circumstances, this Court is of the view that Special Officer should be appointed to enquire as to the sum lying in the bank account of the judgment-debtor. Thus, Ms. Rupsha Chakraborty, learned Advocate and Ms. Suvasree Ghose, learned Advocate (Phone No.9830214490) are

appointed as Special Officers to cause an enquiry as to the amount lying in the bank account of the judgment-debtor, namely, M/s. Shruti Exports. The following bank accounts should be enquired from the Bank Authorities:

Ms. Rupsha Chakraborty, learned Advocate and Ms. Suvasree Ghose, learned Advocate are appointed as Joint Special Officers only for this purpose.

The Report is to be submitted by the Special Officers on completion of enquiry and learned Special Officers shall conduct the enquiry upon notice to the learned Advocate for the parties. The Report be submitted on or before 9th September, 2025. Learned Special Officers are entitled to a remuneration of 800 GM each to be paid by the decree-holder.
