Various objections have been raised by the Registry and each one is dealt with separately as follows :

Objection No.1 - Appellant-in-person is granted two weeks' time to file the complete memo of parties.

Objection No.2 - Overruled.

Objection No.3 - Appellant-in-person states that she will produce Appendix/Annexures before the Court at the time of hearing. She is permitted to do so.

Objection No.4 - Appellant-in-person is granted two weeks' time to file certified copy of the impugned order.
