CC No. 19000/2015:-

It is submitted for the information of the Hon'ble Court that the instant matter has been filed against the Judgment and Order dated 08.04.2013 of the High Court of Delhi at New Delhi in L.A. APP No. 61 of 2013 alongwith application for condonation of delay in filing SLP (barred by time by 821 days) (regd. as I.A. No. 1) and applications for permission to file additional documents and exemption from filing certified copy of the impugned order (unregistered) and the same have been included in SLP paper books.

It is further submitted that SLP(C) No. 10200-10215/2015 @ CC Nos. 1884-1899/2015 arising out of common relied upon order was listed before the Hon'ble Court on 30.03.2015, when the Court was pleased to grant leave. Consequently, C. A. Nos. 3285-3300/2015 has been registered. Copy of order dated 30.03.2015 is enclosed herewith.

It is further submitted that Contempt Petition(C) No. 34 of 2011 in C.A. No. 4115/2009 referred to Annexure P-4 was listed before the Hon'ble Court on 23.08.2011, when the Court

was pleased to dispose of the same with certain observations and directions. Copy of order dated 23.08.2011 is marked as Annexure P-4 at page Nos. 101-102 of SLP paper books.

It is further submitted that I.A. No. 2 in Contempt Petition(C) No. 34 of 2011 in C.A. No. 4115/2009 referred to Annexure P-6 was listed before the Hon'ble Court on 21.02.2012 alongwith connected matter, when the Court was pleased to dispose of the same. Copy of order dated 21.02.2012 is marked as Annexure P-6 at page Nos. 122-123 of SLP paper books.

It is further submitted that SLP(C) No. 22279-22285/2013 @ CC Nos. 17246-17252/2012 referred to Annexure P-7 was listed before the Hon'ble Court on 08.07.2013, when the Court was pleased to grant leave. Consequently, C.A. Nos. 5480-86/2013 has been registered. Copy of order dated 08.07.2013 is marked as Annexure P-7 at page Nos. 124 of SLP paper books.

CC Nos. 19099-100/2015:-

It is submitted for the information of the Hon'ble Court that the instant matter has been filed against the Judgment and Order dated 24.04.2012/correction order dated 26.09.2012 of the High Court of Delhi at New Delhi in L.A. APP Nos. 129/2012 and 130/2012. The matter initially filed on 06.04.2015 was barred by time by 829 days. The matter was found defective and returned to the counsel. He has on 05.10.2015 refiled the matter after curing the defects which is barred by time by 154 days. Counsel for the petitioner has also filed application for permission to file additional documents and exemption from filing certified copy of the impugned order (unregistered). All the applications have been included in SLP paper books.

It is further submitted that SLP(C) No. 25387/2015 @ CC No. 15735/2015 arising out of common followed judgment was listed before the Hon'ble Court on 31.08.2015, when the Court was pleased to grant leave. Consequently, C. A. Nos. 6818/2015

has been registered. Copy of order dated 31.08.2015 is enclosed herewith.
