**UPON hearing the counsel, the Court made the following
O R D E R**

1. We are informed by learned counsel for the parties that they have not been able to arrive at a negotiated settlement before the Supreme Court Mediation Centre in respect of the two flats co-owned by them.
2. Having heard the learned counsel for Ms. Shraddha Gupta [Petitioner in Contempt Petition (Civil) No. 499/2019 & MA No. 2450/2019 & respondent in SLP(C) No. 14759/2018] and Mr. Sumit Vijay Kumar Jain, who appears in-person [petitioner in SLP(C) No. 14759/2018 and respondent in Contempt Petition (Civil) No. 499/2019 & MA No. 2450/2019], it is deemed appropriate to direct both the parties to file their affidavits enclosing therewith a computed statement of the market value of the two flats, the extent of the loans taken by each of the parties against the said flats and the payments made by each of them against the loans taken, for this Court to take a view in the matter.
