Heard learned counsel for the petitioner as also learned counsel for the respondent and perused the petition papers.

Though in the instant case, the petitioner has sought for transfer of the case bearing Matrimonial Suit No. 545 of 2022, titled "Sh Iman Biswas Vs. Smt. Rimpi Biswas (Debnath)", pending before the Court of Addl. 2nd District Judge, Durgapur, West Bengal to the Court of Additional District Judge, Family Court, Bilaspur, Chhattisgarh, we take note that in respect of other transfer petition bearing T.P.(Cr1.) No. 570 of 2021 between the same parties, this court on taking note of all circumstances had indicated that the transfer is to be made to the Jurisdictional Court at Jamshedpur, Jharkhand.

Hence, in the instant petition, we direct the transfer of Matrimonial Suit No. 545 of 2022, titled "Sh Iman Biswas Vs. Smt. Rimpi Biswas (Debnath)", pending before the Court of Addl. 2nd District Judge, Durgapur, West Bengal to the Jurisdictional Court at Jamshedpur, Jharkhand.

Further, in the facts of the present case, we grant liberty to both parties to make an appropriate application before the transferee court to permit them to take part in proceedings through virtual mode. If such request is made, the transferee Court shall take note of the same and permit the parties and insist on the physical presence only when it becomes absolutely necessary.

The Transfer Petition is disposed of in the afore-stated terms.
