OFFICE REPORT

The matter were listed before the Hon'ble Court on 24th March, 2014 when the Court was pleased to pass the following order:-

“Permission to file special leave petitions is granted is S.L.P (Civil) No. /2014 [CC 5079-5081/2014] and delay condoned.

Issue notice returnable in ten weeks.

Dasti, in addition to the ordinary process, is permitted.

Mr. Anip Sachthey, advocate, waives service for respondent Nos. 1 to 3.

Counter affidavit may be filed by respondent Nos. 1 to 3 within six weeks.

Rejoinder, if any, may be filed by the petitioners within four weeks therefrom.

Prayer for interim relief is rejected.

However, it is made clear that tax already paid or to be paid shall be subject to the final decision in the special leave petitions.”

Card nor unserved cover containing the notice has been received back from Proforma respondent Nos. 6 and 8 so far.
