The matters above-mentioned were listed before the Hon'ble Court on 5th July , 2016 when the Hon'ble Court was pleased to pass the following order:-

SLP (C) No. 17432 OF 2014

It is submitted that Service of Notice is complete as all the Respondents are represented through Ms. Kirti R. Mishra, Advocate. Counter and Rejoinder Affidavits have been filed. Copies of the same have been included in the Paper Books.

SLP (C) NO. 11857 OF 2016

It is submitted that there are three respondents. AD Cards duly signed have been received from Respondent Nos.1 and 2, but no one has filed Vakalatnama/ Appearance on their behalf so far.
