SLP (C) No. 17432 OF 2014

The matter above-mentioned was listed before the Hon'ble Court on 2nd February, 2015 when the Hon'ble Court was pleased to pass the following order:-

**“List the matter on a non-miscellaneous day in the last week of February, 2015.
In the meantime, rejoinder affidavit be filed.”**

It is submitted that Counsel for the Petitioner has on 14th March, 2015 filed Rejoinder Affidavit. Copies of the Rejoinder Affidavit have been included in the Paper Books.

SLP (C) NO. 11857 OF 2016

The matter above-mentioned was listed before the Hon'ble Court on 2nd May, 2016 when the Hon'ble Court was pleased to pass the following order:-

**“Issue notice.
Dasti, in addition, is permitted.
In the meanwhile, no coercive process shall be taken against the petitioner for recovery of the demand amount.
Tag with SLP (C) No. 17432 of 2014.”**

Accordingly, show cause notice was issued to all the three respondents on 20th May, 2016 through registered A.D. Post. Neither A.D. Card nor unserved cover containing the show cause notice has been received back from the said Respondents so far.

It is submitted that a Copy of the show cause notice was also given to Mr. B.Balaji, Advocate (Standing Counsel for State of Tamil Nadu) but he has not filed Vakalatnama/Appearance on behalf of the Respondent/State of Tamil Nadu so far.

SLP (C) NO. 11857 OF 2016

The matter above-mentioned was listed before the Hon'ble Court on 20th June, 2016 when the Hon'ble Court was pleased to pass the following order:-

“Issue notice.

Mr. Atul Kumar, learned counsel for the respondent has entered appearance and waives notice.

It is stated that the tax amount including interest is Rs. 13,00,00,000/- (Rupees thirteen crore only) approximately out of which the petitioner has already paid Rs.5,20,00,000/- (Rupees five crore twenty lac only). The remaining amount shall be paid within one month from today. On the said amount being paid, no coercive process shall be taken against the petitioner for the recovery of penalty. The account of the petitioner shall also not be seized on that account.

It is submitted that the sole Respondent is represented through Mr. Atul Kumar , Advocate but he has not filed Counter Affidavit on behalf of the sole Respondent so far.
