OFFICE REPORT

The office report was listed before the Ld. Registrar Court on 7th May, 2015, when the following order was passed:

“The office report indicates that the Ld. Counsel for the petitioner has filed the spare copies of the SLP after the period prescribed for such filing. This delay has been satisfactorily explained by the Ld. Counsel. Therefore, the same is condoned, and, accordingly, notice shall be issued to the respondent Nos. 6 & 8 with utmost dispatch.

It is submitted that show cause notice was issued on 21st May, 2015, to unserved respondent No. 6 (Proforma respondent No. 5 in S.L.P. © No. 9712 of 2014) by registered A.D. Post. Neither A.D. Card nor unserved cover containing the notice has been received back from the said respondent No. 6 so far.

It is further submitted that Dasti notice served through the Trial Court could not be issued as the counsel for the petitioner has not furnished the particulars of Trial Court so far.

It is lastly submitted that counsel for respondent Nos. 1, 2, 3, 5 and 7 has on 11th June, 2015 filed counter affidavit. Counsel for respondent No. 8 (Proforma respondent No. 4 in S.L.P. © No. 9713 of 2014) has not filed counter affidavit so far. Inadvertantly, in the office report dated 6th May, 2015 respondent No. 8 was shown as unserved instead of respondent No. 4. Service of notice is incomplete in respect of respondent Nos. 4 (Proforma respondent No. 4 in S.L.P. © No. 9711 of 2014) and 6 (Proforma respondent No. 5 in S.L.P. © No. 9712 of 2014). Inconvenience caused to the Ld. Registrar Court is regretted.

The office report is listed before the Ld. Registrar Court for orders.
