UPON hearing counsel the Court made the following
O R D E R

We have seen the order dated 10th

September, 2010, passed by the learned Judge in Chambers, which indicates that some of the Special Leave Petitions were directed to be listed before the learned Judge in Chambers for dismissal on the ground of non-prosecution. The said matters have

now been listed before this Court on the basis of the order of the learned Judge in Chambers dated 29th October, 2010, for dismissal on the ground of non-prosecution.

However, learned counsel appearing
