O R D E R

In terms of order dated 25.02.2022, the respondent has brought a bank draft in the sum of Rs. 2 crores drawn in favour of the appellant-Bhupinder Kochhar. There has been

delay in depositing the amount in terms of the order which stands condoned by consent.

The bank draft drawn in favour of the appellant is made over to the learned counsel for the appellant. The appellant has filed an affidavit of undertaking to vacate the premises within three months from the date of receipt of the amount. That period will start from today.

In other words, the appellant along with any other persons residing with him shall vacate the premises on or before 18.07.2022, failing which, further action, as may be necessary, would be initiated against the appellant and anyone obstructing the handing over of the possession of the suit premises to the respondent.

If the vacant and peaceful possession of the suit premises is not handed over to the respondent before the date specified, the appellant shall personally remain present in the Court on the next date.
