CIVIL APPEAL NOS. 2872/2010 & 2873/2010

The matters above mentioned were listed before Hon'ble

Judge in Chambers on 19.07.2013 when His Lordship was pleased to pass the following order:

"C.A. NO.2872/2010

On the oral prayer made by the learned counsel for the appellant, delay in filing the statement of case by the appellant is condoned. Office to take the same on record.

Four weeks' further time is granted to respondent No.3, as a last chance, to file statement of case.

C.A. No.2873/2010

Appellants are granted four weeks' further time, as a last chance, to file statement of case."

Civil Appeal No. 2872/2010

It is submitted that there are 4 respondents in this appeal. Service of notice of Lodgement of Petition of Appeal is complete on all the respondents. Respondent No. 1 is represented by Mr. V.P. Appan, Advocate and Respondent No. 3 is represented by Mr. Aftab Ali Khan, Advocate. Respondent Nos. 2 and 4 have already been served at SLP stage but nobody has entered appearance on their behalf.

It is further submitted that counsel for the appellant and Respondent No.1 have filed statement of case. Counsel for Respondent No.3 has not filed the statement of case, so far, despite Hon'ble Chamber Judge Order dated 19.07.2013. List of dates has been filed in this matter, hence Civil Appeal may be treated as ready.

Original record has been received and available with the Registry for reference of the Hon'ble Court.

Civil Appeal is ready.

Civil Appeal No. 2873/2010

It is submitted that there are 5 respondents in this appeal. Service of notice of Lodgment of Petition of Appeal is complete on all the respondents but no one has entered appearance on their behalf, so far.

Common Original record in connected Civil Appeal No. 2872/2010 has been received from the High Court.

It is further submitted that counsel for the appellant has not filed statement of case and list of dates has been filed in this matter, hence Civil Appeal may be treated as ready.

Civil Appeal is ready.

SLP (C) NO. 23393/2010

The matter above mentioned was listed before the Hon'ble Court on 17.08.2010, when the Court was pleased to pass the following order:-

"Issue notice.

Mr. Gaurav Kejriwal, Advocate appears and waives service of notice on behalf of sole Respondent.

Post along with SLP(C) No. 15770 of 2009.

In the meanwhile, there shall be stay of contempt proceedings."

It is submitted that pursuant to aforesaid order Show Cause Notice to sole Respondent was issued through Mr. Gaurav Kejriwal, Advocate on 15.09.2010. He has on 21.09.2010 filed Counter Affidavit with Annexures R-1 to R-13 and the same have been included in the SLP paper books.

Service is complete.

SLP (C) NO. 12481/2006

Pursuant to this Hon'ble Court's order dated 11.08.2006 Show Cause Notice to all the three Respondents was issued on 01.09.2006 by courier. Respondent Nos. 1 and 2 are represented by Ms. Sushma Suri, Advocate, Respondent No.3 is represented by Mr. P.N. Puri, Advocate. Counsel appearing for Respondent Nos. 1 to 3 have filed their respective Counter Affidavits and the same have been included in SLP paper books. No Rejoinder Affidavit has been filed.

It is submitted that SLP was dismissed alongwith main matter i.e. Civil Appeal No. 5319/2003 vide this Hon'ble Court's order dated 24.11.2009 and the same was restored vide Hon'ble Court's Order dated 01.09.2010 alongwith main matter i.e. IA No. 6 in SLP(C) No. 27164/2008. SLP(C) No. 27164/2008 converted into Civil Appeal No. 32/2013 and the same has been re-tagged vide Hon'ble Court's Order dated 31/08/2012.

Service is complete.

CIVIL APPEAL NO. 2492/2011

It is submitted that there is sole Respondent in this appeal. Service of Notice of Lodgment of Petition of Appeal is complete. Sole Respondent is served through notice but no one has entered appearance, so far.

Original Record has been received from the High Court and is available with the Registry for reference of the Court.

It is further submitted that counsel for the appellant has filed statement of case.

CIVIL APPEAL NO. 2949/2014

It is submitted that there are 2 respondents in this appeal. Respondent No.1 is represented by Mr. D.S. Mahra, Advocate. Respondent No. 2 has been served at SLP stage but no one has entered appearance so far.

Service of notice of lodgment of petition of appeal is complete.

Scanned original Record has been received from the High Court. Counsel for the parties have not filed statement of case so far.

SLP (C) NO. 23102/2011

The matter above mentioned was listed before the Hon'ble Court on 12.08.2011, when the Court was pleased to pass the following order:-

"Delay condoned.

Issue notice.

Tag with C.A. No. 2872 of 2010 and connected matters.."

It is submitted that pursuant to aforesaid order, notice to sole Respondent was issued on 16.09.2011. Mr. Raj Singh Rana, Advocate has filed Vakalatnama/Appearance on behalf of sole Respondent but has not filed Counter Affidavit, so far.

It is further submitted that IA No.2 (Application for stay) was listed before the Hon'ble Court on 13.02.2013 with office report dated 13.02.2013 when the Court was pleased to inter-alia pass the following order:-

"...I.A. No. 1 of 2012 in S.L.P. (C) No 29515 of 2010 and I.A No. 2 in S.L.P. (C) No 23102 of 2011:

Having regard to the issues involved in

the Special Leave Petitions, we expect the matters to be listed before a larger Bench at an early date.

I.A. No. 1 of 2012 in S.L.P. (C) No 29515 of 2010 and I.A No. 2 in S.L.P. (C) No 23102 of 2011 shall be considered at the time of final hearing of Special Leave Petitions."

Service is complete.

SLP (C) NO. 32839/2011

It is submitted that respondent-in-person has already filed Counter Affidavit and the same has been included in SLP paper books.

Service is already complete.

CIVIL APPEAL NOS. 295-296/2012

It is submitted that there are 3 respondents in these appeals. Service of Notice of Lodgment of Petition of Appeal is complete on all the respondents. Respondent No. 1 is represented by Mr. A. K. Sharma, Advocate. No one has entered appearance on behalf of respondent Nos. 2 and 3 so far though served with notice.

Original Record has been received from the High Court.

It is lastly submitted that counsel for the appearing parties have filed their respective statement of case. Counter and rejoinder affidavits have been filed at SLP stage.

The appeals are 'Ready' for hearing.

SLP (C) NOS. 3599-3600/2012 & 3604-3605/2012

It is submitted that there are 15 Respondents in both the matters. Mr. B.K. Prasad, Advocate has filed Vakalatnama/Appearance on behalf of Respondent Nos. 1 and 2 but he has not filed Counter Affidavit, so far. Respondent Nos. 3 to 15 have been deleted vide Hon'ble Chamber Judge Orders dated 17.01.2012 and 15.04.2013 and cause title has been amended and placed in SLP paper books.

It is submitted that in SLP(C) No. 3604-3605/2012 counsel for the petitioner has filed application for modification of Court's Order dated 17.01.2012 (regd. as I.A. Nos. 10-11) and the same has been included in SLP paper books.

Service is complete.

SLP (C) NO. 26437/2012

It is submitted that as directed vide Hon'ble Court's order dated 31.08.2012 notice was issued to all the 30 Respondents on 08.10.2012 by Regd. AD. AD cards have been received in respect of Respondent Nos. 2 to 4, 6, 7, 11 to 13, 15 to 20, 22 to 24, 26 & 28 to 30 but no one has entered appearance, so far. Respondent Nos. 5, 8 to 10, 14, 21, 25 and 27 have been dismissed vide Hon'ble Chamber Judge Order dated 31.03.2014 and cause title has been amended and placed in SLP paper books. Respondent No.1 is appearing in-person and has on 21.11.2012 filed Counter Affidavit and the same has been included in SLP paper books.

Service is complete.

SLP (C) NO. 35330/2012

It is submitted that proforma Respondent Nos. 6 to 32 have been deleted from the array of parties vide Hon'ble Chamber Judge Order dated 01.04.2013 and cause title has been amended and placed in SLP paper books.

It is further submitted that Show Cause Notice to Respondent Nos. 1 to 5 was issued on 09.04.2013 by Regd. AD. Mr. D.S. Mahra, Advocate has filed Vakalatnama/Appearance on behalf of Respondent nos. 1 to 2 but has not filed Counter Affidavit, so far. No one has entered appearance on behalf of Respondent Nos. 3 to 5 though served.

Service is complete.

SLP (C) NO. 2720/2012

Pursuant to Hon'ble Court's order dated 03.02.2012 Show Cause Notice to sole Respondent was issued on 03.03.2012 by Regd. AD. AD card duly signed has been received but no one has entered appearance, so far. Counsel for the petitioner has on 10/11/2014 has filed Memo of Understanding dated 15/5/2006 with the permission of the Hon'ble Court and same is being circulated herewith.

service is complete.

SLP (C) NOS. 3469-3472/2012

It is submitted that there is sole Respondent in each SLP. Show Cause Notice to each of the Respondent was issued on 03.03.2012. sole respondent in each matter has not entered appearance though served with notice.

Service is complete.

SLP (C) NO. NOS. 15725-26/2012

It is submitted that there is sole Respondent in each SLP. Both the Respondents have not entered appearance though served with notice by Regd. AD/Dasti on 11.06.2012 and 07.12.2012.

Service is complete.

SLP (C) NO. 25091/2013

The matter above mentioned was listed before the Hon'ble Court on 02.08.2013, when the Court was pleased to pass the following order:-

"Delay condoned.

Issue notice. In the meanwhile, there shall be stay of further meeting of Departmental Promotion Committee (DPC).

List and tag with Civil Appeal No. 2872/2010."

It is submitted that pursuant to aforesaid order Show Cause Notice to sole Respondent was issued through advocate on record on 26.09.2013. Counter affidavit filed by him has been included in SLP paper books.

Service is complete.
