Application for hearing in open Court is rejected.

Delay in preferring this Review Petition is condoned.

While rejecting the challenge to the decision of the Industrial Court, the High Court considered whether the settlement arrived at in the present matter had the effect of “closure of the undertaking”. It was held, “...
...what has been done is only the transfer of the workmen to an

associate/subsidiary company of the Respondent No.1 herein i.e. the Respondent No.6 herein. However, the other business activities of the Respondent No.1 are continued at SEEPZ.” The High Court also considered the effect of the decision of this Court in ***Jawaharlal Nehru University vs. Dr. K.S. Jawatkar and others***¹ case.

The conclusions arrived at by the High Court were affirmed by this Court while dismissing Special Leave Petition arising from the decision of the High Court.

We have gone through the grounds taken in the Review Petition and do not find any error apparent on record to justify interference. This Review Petition is, therefore, dismissed.
