UPON hearing counsel the Court made the following
O R D E R

In SLP(C) Nos.934, 935/10 and 20832/09 the application for substitution filed by the respective petitioners are still defective. Ld.counsel for the petitioner in each of the above case is granted four weeks time for curing the above defects.

In SLP(C) No.1317/10 Substitution Application has been filed to bring on record the Lrs. of deceased respondent No.8, which may be processed and listed before the Hon'ble Judge in Chambers as per rules.

In SLP(C) No.935/10 respondent Nos. 29, 30, 32 and 34 have refused to accept dasti notice. Hence, Ld.counsel for the petitioner is directed to take out fresh steps against the above respondents.

In SLP(C) Nos. 1315 and 1011/10 Ld.counsel for the petitioner is granted four weeks time for taking fresh steps against the Lrs of deceased respondent Nos. 10 and 17.

In SLP(C) No.923/10 Ld.counsel for the petitioner was directed to file additional affidavit stating that whether the person on whom the notices have been served personally were they staying with the corresponding respondents, have not filed the additional affidavit. Granted four weeks time for filing additional affidavit as a last chance or taking fresh steps against such of the unserved respondents.

In SLP(C) No.4707/10 petitioner is granted four weeks time as a last chance for taking fresh steps against respondent Nos.24, 61 and 92.

In SLP(C) No.4708/10 Ld.counsel for the petitioner is granted four weeks time to take fresh steps against

the Lrs. of deceased respondent No.4.

In SLP(C) No.15659/10 petitioner is granted four weeks time as a last chance for taking fresh steps against respondent No.9.

In all other remaining cases, await return of notice of the unserved respondents. The served respondents are granted four weeks time as a last chance for filing counter affidavit.
