**OFFICE REPORT**

The matter above-mentioned was listed before the Hon'ble Court on 1<sup>st</sup> April, 2015, when the Court was pleased to pass the following order:-

**"Issue notice.**

Pending further orders, we direct that in case the petitioner is arrested in connection with M.E.C.R.No. 3 of 2013 registered at Gamdevi Police Station which is renumbered as M.E.C.R. No. 1 of 2014 and transferred to Crime Branch, C.I.D. Unit-II, Mumbai he shall be enlarged on bail on his furnishing bail bonds in a sum of Rs. 20,000/- with two sureties in the like amount to the satisfaction of the Officer effecting the arrest. The petitioner shall however at all times co-operate with the on-going investigation and shall refrain from tampering with the evidence whatsoever."

Accordingly, show cause notice was issued to both the Respondents in the matter.

It is submitted that Mr. Nishant R. Katneshwarkar, Advocate has filed Vakalatnama/Appearance and Counter Affidavit on behalf of Respondent No.1. Mr. Arvind S. Awadh, Advocate representing the Respondent No.2. Further M/s. Karanjawala & Co., Advocate has filed Rejoinder Affidavit in the matter. The aforesaid Counter Affidavit and Rejoinder Affidavit have been included in the Paper Books.

The service of show cause notice is complete.

It is further submitted that Mr. Arvind S. Awadh, Advocate has filed Application for Vacating Interim Relief on behalf of Respondent No.2 and the same has been registered as Criminal Miscellaneous Petition No.15514 of 2015. The aforesaid application was listed
