SLP(C) D. No. 3447/2025

Matter is already directed to be listed before Hon'ble Court vide order dated 22.09.2025.

SLP(C) No. 6960/2025

Respondent Nos. 1 to 5 have not filed counter affidavit despite last opportunity. Hence, further opportunity to file counter affidavit is hereby declined.

Counter affidavit on behalf respondent Nos. 7 to 14 be filed on or before 12.1.2026, as last chance.

If the same is filed, be taken on record.

In case not filed, further opportunity to file the same is declined.

Ld. Counsel for Petitioner has failed to affidavit of dasti service in respect of Respondent Nos. 8 and 12, though last opportunity was granted.
