SLP (C) (Diary) No.3447/2025

Four weeks' time is granted to learned counsel for respondent
Nos.1 to 6 to file counter affidavit.

Four weeks' time as last opportunity is granted to respondent Nos.7 & 8 to file counter affidavit.

After expiry of 4 weeks, list the matter before Hon'ble Court as per rules.
