No. 101 of 2008, R.P. No. 180 of 2008, W.A. No. 2529 of 2005, R.P. No. 55 of 2008(J), W.P(C)No. 939 of 2006, W.P(C)No. 31530 of 2007(C), W.P(C)No. 3704 of 2008(N), R.P. No. 983 of 2007 and W.P(C)No. 30527 of 2005, W.P(C) No. 5311 of 2009(H), R.P.
