Heard learned counsel appearing for the parties and perused the record.

For the reasons stated in the interlocutory applications, the names of respondent nos.12 and 13 in SLP(C) No.4972 of 2010, are deleted from the array of parties at the risk of the petitioners.

The special leave petitions are dismissed.

However, in the facts and circumstances of these cases, we consider it appropriate to direct the respondents i.e. the State of Chhattisgarh and the Public Service Commission, not to bar the petitioners on the ground of age, if they apply for the posts of Principal, in pursuance of advertisement of fresh recruitment. We order accordingly.

No orders need be passed on the application for intervention filed in SLP(C) No.2453 of 2011.

As a sequel to the above, pending interlocutory applications, if any, stand disposed of.
