OFFICE REPORT

SLP(C) No. 4972 & 14375 of 2010

It is submitted that there are common 13 respondents in these two matters above mentioned. Mr. Farooq Rasheed, Advocate has filed vakalatnama/appearance on behalf of Respondent no. 1 in SLP 4972/2010 and Ms. A.P. Mayee filed vakalatnama/appearance on behalf of Respondent No. 1 in SLP 14375 of 2010. Mr. D.K. Sinha, Advocate has filed counter affidavit in both the matters on behalf of Respondent No.3, copy of the same has been included in the paper books.

It is further submitted that Counsel for the petitioners has already filed affidavit of Dasti service in respect of all the respondents in both the matters. But no one has entered appearance on their behalf Respondent Nos. 2, 4 to 11.

It is further submitted that Ms. Sharmila Upadhyay, Advocate has filed vakalatnama/appearance on behalf of common respondent nos. 12 & 13 along with applications for deletion the name of respondent nos. 12 & 13 which is registered as I.A Nos. 5 & 6 in SLP (C) No. 4972/2010 and copies of the same have

already been included in the paper books.

It is lastly submitted that Mr. Neeraj Shekhar, Advocate has on 10.03.2017 filed application for permission to file additional documents with affidavit and annexures and also application for exemption from filing O.T. in SLP No. 4972 of 2010, but no affidavit in support of annexures A-1 to A-2 is filed. The same is being circulated with this office report.

SLP(C) No. 2453/2011

It is submitted that there are 5 respondents Mr. D.K. Sinha, Advocate has filed vakalatnama on behalf of respondent no. 1 & 2 and filed counter affidavit on behalf of Chhattisgarh Public Service Commission. Copy of the same has already included in the Paper Books. Counsel for the petitioner has also filed affidavit of Dasti service in respect of all the five respondents but no one has entered appearance on behalf of Lrs Nos. 3 to 5.

It is further submitted that Mr. Kunal Verma, counsel for the petitioner has on 24.01.2014 filed an application for intervention along with vakalatnama/appearance on behalf of the proposed intervenor. The said application has been registered as I.A. No. 3 and copy of the same has already been included in the paper books.

Service of show cause notice is complete.
