OFFICE REPORT ON DEFAULT

The matter above mentioned was listed before the Hon'ble Court on 06.05.2013, when the court was pleased to pass the following order:-

" Heard.

Delay condoned.

Issue notice.

Copy of the Notification dated 10.06.2003 Ex.D-4 and the site plan, relied upon by the petitioners, before the trial court be filed in the meantime."

Accordingly. Show cause notice to all the six respondents was issued on 30.05.2013 through registered A.D. Post. A.D. Cards duly signed have been received back from Respondent Nos. 4-6 but there is no appearance on their behalf. Neither A.D. card nor unserved cover containing notice has been received back from Respondent nos.1-3. For completion of service of show cause notice on Respondent Nos. 1-3, the matter was listed before the Ld. Registrar's Court time and again and on 31.10.2014, the Ld. Registrar granted three weeks time as last chance to take fresh steps for the service of show cause notice by usual mode and by way of Dasti permitted to be served through the Trial Court, the particulars of which shall be furnished by the ld.Counsel for the petitioners. However, Counsel has not done the needful

and the matter above mentioned was lastly listed before the Ld. Registrar's Court on 15.01.2015, when the following Order was passed:-

" The office report states that although by Order dated 31.10.2014 of this Court three weeks time, as last chance, was given to the learned counsel for the petitioners for taking fresh steps for the service of notice to the unserved respondent Nos. 1 to 3, yet he has not done the needful so far. Viewed in that context, the matter shall be processed for listing before the Hon'ble Judge in Chambers for further future directions. Await orders and list thereafter."

It is submitted that Counsel for the petitioners has on 20.01.2015 after the direction of the Ld. Registrar, filed spare copy of SLP but the particulars of Trial Court has not been furnished by the Counsel.

The default on the part of the Counsel for the petitioner is reported to the Hon'ble Court (In Chamber) with this office report.
