OFFICE REPORT

It is submitted that the instant Civil Appeals alongwith connected matters were listed before the Hon'ble Court on 15th December, 2016 when the Hon'ble Court disposed of the same. Copy of the Judgment is annexed with respective application paper books.

The Interlocutory application Nos. 4-6 and 7-9 in C. A. Nos.12164-12166 of 2016 and 5-6 in C.A. No. 12169 of 2016 were listed before the Hon'ble Court on 6th February, 2017, when the Court was pleased to pass the following order:-

"We are of the opinion that these applications may be listed before a Bench comprising one of us (Dr. D.Y.Chandrachud, J.) and Hon'ble Mr. Justice L. Nageswara Rao subject to orders of Hon'ble the Chief Justice of India.

The matter may be listed within two weeks.

The interlocutory applications which are circulated in the matter shall also be numbered by the Registry."

It is submitted that Mr. Ardhendumauli Kumar Prasad, Advocate has on 28th February, 2017, filed Review Petition alongwith permission to file Review Petition in C.A. Nos. 12164-12166 of 2016 on behalf of state of Uttar Pradesh through Principal Secretary, Excise, which is defective as the cause title is not proper. As the matter is on board, the same is being circulated.

It is further submitted that Mr. Sanjay Madhavrao Ghatage, resident of Kohlapur, Maharashtra, has sent a letter through e-mail in C.A. Nos. 12164-121666 of 2016 stating therein that it may be the representation may be considered as Review Petition as it involves interest of public at large and lakhs workers engaged in this. It is lastly submitted that Mr. Suvidutt M.S., Advocate has on 23rd March, 2017 filed a Contempt Petition(D. No. 9250 of 2017) against Pinayari Vijayan, Chief Minister, Government of Kerela for willful disobedience of the order of this Hon'ble Court dated 15th December, 2016 in C.A. Nos. 12164-121666 of 2016 but the same is defective for the reason

- a) Complete addresses of the alleged contemnors is not given.
- b) Complete Civil Appeal cause title not given.
- c) Paragraph regarding first contempt petition against order dated 15th December, 2016 is not given. As the matter is on board unregistered contempt petition may be circulated with office report.

It is lastly submitted that Mr. Mishra Saurabh, standing counsel for the State of Madhya Pradesh has on 24th March, 2017 filed affidavit in compliance of order of this Hon'ble court dated 15th December, 2016.

CIVIL APPEAL NO. 12169 OF 2016

It is submitted that Mr. A. Venayagam Balan, Advocate, has on 2nd February, 2017, filed an application for direction/modification and impleadment in Civil Appeal No. 12169 of 2016 on behalf of Puducherry Anaithu Madhupana,

As the matter is on board, the Interlocutory Applications for impleadment and clarification of Court's order dated 15.12.2016 are being circulated before the Hon'ble Court.

CIVIL APPEAL NO. 12170 OF 2016

It is submitted that Mr. Rakesh K. Sharma, Advocate has on 14th February, 2017, filed an application for direction to exempt the applicants from the order dated 15.12.2016 on behalf of the Appellant, Mahe Liquor Merchants Association. As the matter is on board, unregistered application for direction is circulated before the Hon'ble Court.

It is further submitted that Mr. Rakesh K. Sharma, Advocate has on 14th February, 2017, filed an application for direction on behalf of the appellant Mahe Liquor Merchants Association but the prayer portion is not proper. As the matter is on board, Interlocutory Application for direction is circulated before the Hon'ble Court.
