UPON hearing counsel the Court made the following
O R D E R

As per office report, the States of Andhra Pradesh, Haryana, Jharkhand, Madhya Pradesh, Orissa, Uttrakhand, West Bengal, Government of N.C.T. of Delhi, Goa, Pondichery and Union Territory of Lakshdweep have not so far filed their respective affidavits in terms of our order dated 16th November, 2010.

Learned counsel appearing for the States of Madhya Pradesh, Orissa, Uttrakhand and Pondichery submit that the requisite information is being collected and the affidavit shall be filed within four weeks. Let them do so. At the same time, we grant one more opportunity to the States of Andhra Pradesh, Haryana, Jharkhand, West Bengal, Government of N.C.T. of Delhi and Goa to file their requisite affidavits within four weeks, failing which the Chief Secretaries of the said States shall personally remain present in Court to enable us to make appropriate orders. A copy of this order shall be forwarded by the Registry to the officers concerned forthwith.
