These are appeals by special leave from the Judgment and Order dated 3.12.2008 of the High Court of Orissa at Cuttack in W.P (C No. 16134 of 2008 and 16104 of 2008 respectively.

It is submitted for the information of the Hon'ble Court that there are 7 Respondents (common in both Appeals).
