O R D E R

1. The parties have favourably responded to the suggestion of the Court that an amicable solution be explored through the process of mediation.
2. Let the matters be referred to the Supreme Court Mediation Centre. Parties to appear before the Coordinator, Supreme Court Mediation Centre on 08th May, 2026 at 11.00 a.m.

3. The first meeting with the coordinator shall be virtual. The learned Mediator appointed by the Supreme Court Mediation Centre is requested to conduct the proceedings, as far as possible, through the medium of video conferencing

4. In the event, the learned Mediator desires personal presence of the parties, they shall undertake to appear physically.

5. It is brought to our notice that Bhaswar Sharma son of Birender Pratap Sharma who is petitioner no.3 in T.P. (Crl.)Nos.112-113/2026 and is also sole petitioner in T.P. (Crl.)No.114/2026 and in T.P.(C) No. 384/2026, is in judicial custody and is lodged in Gorakhpur Jail, Uttar Pradesh. Since parties are agreed for mediation, the petitioner- Bhaswar Sharma son of Birender Pratap Sharma, shall participate through video conference from the concerned jail. For this purpose, the Superintendent, Gorakhpur Jail, Uttar Pradesh may make such arrangements as are required to enable the participation of the petitioner through video conferencing from the concerned jail during the mediation proceedings before the aforesaid Mediation Centre.

6. Call on 22nd July, 2026 after receipt of the report from the Mediator.
