Let the copy be served on the petitioners at the earliest so that rejoinder affidavit, if any, may be filed by the petitioners well in time.

List the Special Leave Petitions on 12-8-2014."

It is submitted that show cause notice as directed could not be issued in the matter as Counsel for the Petitioners have not filed spare copies of the Special Leave Petition required for issuance of notice

It is further submitted that counsel for the petitioner has on 07.08.2014 filed proof of service of copy of Special Leave Petition on Mr. Joseph Aristotle, Advocate for the State of Karnataka in all the matters.

It is further submitted that Mr. Joseph Aristotle, Advocate has on 09.08.2014 filed memo of appearance in respect of State of Karnataka in all the matters and vakalatnama/appearance on behalf of the sole respondent in Special Leave Petition(Crl.) No 5897 of 2014.

It is further submitted that Counsel for the Respondent has not filed counter affidavit, hence no rejoinder.

It is further submitted that Mr. Chandra Prakash, Advocate has on 11.8.2014 filed application for intervention and vakalatnama/appearance in all the matters which has been registered as Crl.M.P. No. 16175, 16177, 16182 & 16181 of 2014 Copy of same is being circulated herewith for kind perusal of the Hon'ble Court.

It is further submitted that Mr. Nitin Kr. Thakur, Advocate has entered caveat on behalf of the Respondent No.3 in Special Leave Petition(Crl.) Nos. 5900 of 2014 and on behalf of the complainant in Special Leave Petition(Crl.) No 5844 and 6001 of 2014.

It is further submitted that Special Leave Petition(Crl.) No 1398-1399 of 2012 relating to same criminal case was dismissed by the Hon'ble Court on 27.02.2012. A copy of Record of Proceedings dated 27.02.2012 is enclosed herewith for kind

perusal of the Hon'ble Court.

It is further submitted that Special Leave Petition(Crl.) No 5897, 5900, 6001 of 2014 has been tagged with Special Leave Petition(Crl.) No 5844 of 2014 as all are arising out of common order.

The matter above mentioned alongwith applications are therefore listed before Hon'ble Court with this office report.
