UPON hearing the counsel the Court made the following
O R D E R

1. The learned counsel for the petitioner submits that the petitioner, who has been convicted for an offence punishable under Section 138 of the Negotiable Instruments Act, 1882 for dishonor of three cheque(s) of Rs. 2 lacs each, had sought compounding of the offence(s)

and, pursuant to the order of the trial court, deposited Rs. 2.54 lacs against each of the three cheques of Rs. 2 lacs.

2. It is submitted that the petitioner is willing to deposit three cheques of Rs.3 lacs each against dishonor of 3 cheques of Rs. Two lacs each and, therefore, his application for compounding be considered on merits.
3. Issue notice, returnable in eight weeks.
4. In the meantime, if the petitioner deposits Rs. 9 lacs (i.e., three cheques /drafts of Rs. 3 lacs) in the Registry of this Court, within six weeks from today, further proceedings of Criminal Appeal Nos. 133/2023, 134/2023 and 136 of 2023 pending in the Court of Additional Sessions Judge, South East District, Saket Court, New Delhi shall remain stayed.
5. The amount so deposited shall be kept in a term deposit of a nationalized bank and shall abide the decision of this Court.
