## O R D E R

1. Delay condoned.
2. This application has been moved seeking modification of the

order dated 05.01.2023 passed in SLP (Civil) No.609/2023, whereby Justice A. Ramalingeswara Rao, former Judge of the High Court of Judicature at Hyderabad for the State of Telangana and the State of Andhra Pradesh was appointed as the sole arbitrator.
