OFFICE REPORT

The matter above mentioned has been filed by Ms. Liz Mathew, Advocate on behalf of Petitioner against the final Judgment and Order dated 07.12.2015 of the High Court of Punjab and Haryana at Chandigarh in COCP No. 1946 of 2015.

It is submitted that Counsel for the petitioner has not filed copies of orders dated 21.02.2011 and 27.09.2012 mentioned in the impugned order. In this regard he has filed a letter dated 12.01.2016 stating therein that these are not required for the purpose of hearing. A copy of the Record of Proceedings dated 23.11.2015 is enclosed herewith for perusal of the Hon'ble Court.

It is lastly submitted that Ms. Abha Jain, Advocate has on 17.12.2015 entered Caveat alongwith Vakalatnama/Appearance on behalf of Respondent No. 1.

The application for permission to file Special Leave Petition is listed before the Hon'ble Court with this office report.
