At the request of learned counsel appearing for the parties time to deposit all instalments simultaneously is extended upto 27th April, 2001. However, it is made clear that previous order passed by this Court directing the State Government as well as the West Bengal Pollution Control Board to disconnect the electricity and water supply is not modified in any way. For the present it stands.

However, those tanneries, who have paid the full amount before 15th April, 2001 their electricity and water connection be restored.

In the meantime, Chinese Tannery is directed to deposit the amount of Rs.6,54,865/- expenses incurred by the Central Leather Research Institute for submitting two reports pursuant to the orders of this Court dated 8th May, 2000 and 18th October, 2000.

List these matters on 27th April, 2001 for further orders.
