OFFICE REPORT

It is submitted to the Hon'ble Court that in these cross appeals Land Acquisition Officer is challenging the order of the High Court enhancing the compensation and claimants are seeking further enhancement of compensation.

The matters (CA Nos. 8263/2009 and CA No. 4981/2010) above-mentioned were listed before the Ld. Registrar Court on 2nd September, 2013, when he was pleased to pass the following order:

“Service is complete. No appearance for the respondent. Appellant has filed the statement of case. No further steps. List the matter before the Hon'ble Court as per rules.”

C.A. NO. 8263 OF 2009

It is further submitted that there were total fifteen respondents in the Appeal above-mentioned the names of Respondent Nos.2 to 15 has been deleted vide Court's Order dated 12th April, 2010. Certificate of service in respect of respondent no.1 (Land Acquisition Officer-cum-RDO, Madanapalle, Chittoor District, A.P.) [Now Sole Respondent]. has been received from the High Court, but no one has entered appearance so far.

Service is complete.

In compliance of circulars dated 3rd December, 2014 and 5th December, 2014 original records have been sent back.

It is further submitted that Ms. Anu Gupta, Counsel for the Appellant has on 31st August, 2012 filed statement of case.

Civil Appeal Nos. 4981-4982 of 2010

It is submitted to the Hon'ble Court that both the appeals filed by the Land Acquisition Officer against the High court order regarding compensation of the claimants at Rs. 1,50,000/- per acre and all other statutory benefits as per amended provision of the Act.

The office report on default in the matter above-mentioned has listed before the Hon'ble Court in Chamber on 12th January, 2015 when the Hon'ble Court was pleased to pass the following order:

“Four weeks' time, by way of last opportunity, is granted to the appellant to file appropriate application for bringing on record the legal representatives of deceased respondent no. 9-K. Lakshmidamma in C.A. No. 4982/2010.”

It is submitted to the Hon'ble Court that counsel for the appellant has not filed an application for bringing on record the LR. of deceased Respondent no. 9 (i.e. K. Lashmidamma) in C.A. No. 4982 of 2010 so far.

It is further submitted to the Hon'ble Court that K. Lakshmidamma is Respondent No. 9 in CA No. 4982 of 2010 and Respondent No. 8 in CA No. 4981 of 2010. She is reported to have died. She is represented by Lrs. in CA No. 4981 of 2010 but no steps have been taken for bringing on record the Lrs. of said common deceased Respondent No. 9 in CA No. 4982 of 2010 so far.

It is further submitted that there are total 15 Respondents each in both the Civil Appeal i.e CA No. 4981 of 2010 and 4982 of 2010. The following Respondents are common in both the Appeal.

In compliance of circulars dated 3rd December, 2014 and 5th December, 2014 Original records have been sent back and notice regarding authentication of Original record and statement of case as envisaged under Order XIX Rule 32(1), Supreme Court Rules, 2013 has not been issued.

It is submitted that notice of hearing for listing the matters on 7th April, 2015 was issued to the common Respondent No. 11 in CA No. 4981 of 2010, Respondent No. 1 in CA No. 4982 of 2010, Respondent No. 11 in CA No. 8418 of 2013 and Respondent No. 12 in CA No. 8419 of 2013 on 17th /19th March, 2015. Neither A. D. Card nor unserved cover containing notice of hearing has been received back.

The appeals above-mentioned are listed before the Hon'ble Court with this office report.
