PETITION FOR SPECIAL LEAVE TO APPEAL (CRL.) No. 828 OF 2013

The matter above mentioned was listed before the Hon'ble Court on 28.01.2013 when the Hon'ble Court was pleased to pass the following order:

Issue notice, returnable four weeks hence.

In the meantime, the petitioner should not be arrested in connection with Complaint Case No.344 dated 1st October, 2008, titled Mukand Singh Vs. Balraj Singh & Ors., pending before the Court of learned Judicial Magistrate, 1st Class, Barnala, Punjab. "
