O R D E R

Learned senior counsel appearing for the petitioner states, on instructions, that the petitioner, S. Aravind, would be willing to offer a larger extent of 600 sq. mtrs. of land in exchange for the area, which has now been earmarked as a park, which was his means

of access to his house, and that he would spend upto ₹10,00,000/- (Rupees ten lakhs only) for establishing the park on the land proposed to be offered by him.

Issue notice, returnable on 08.04.2026.

Ms. Purnima Krishna, learned counsel, who is present in Court on caveat/advance notice, waives service and accepts notice on behalf of respondent Nos. 1 and 2. Hence, notice need not be served on the said respondents.

The respondents shall consider the proposal made today by the learned senior counsel for the petitioner and indicate their decision thereon in their counter affidavit/reply.

As we are informed that a decision in that regard may have to be taken at the level of the Department of Housing and Urban Development, Government of Tamil Nadu, we *suo motu* implead the said Department represented by its Secretary, as respondent No. 3 in this special leave petition.

Notice may also be issued to the newly impleaded respondent No. 3, which shall be served by all modes, including *dasti*.
