It is brought to our notice that the dispute in this case has practically been settled in view of the order dated 30.7.1999 made by the appellant regularising the services of respondent No. 1.

Now the only question to be decided is one relating to the monetary benefits which should be given to the respondent No.1. The High Court has directed that such payment should be made from 27.7.1988. Considering the facts and circumstances, we think it appropriate to limit such liability to 50% of the claim. Subject to the modification to this extent, the appeal shall stand disposed of. Let such payment of arrears be made within three months from today.
