O R D E R

1. Leave granted.
2. Heard learned counsel for the parties.
3. This appeal arises from an order dated 01.12.2025 passed by the High Court of Gujarat at Ahmedabad rejecting the anticipatory bail prayer of the appellant in connection with FIR No. 11216005240881/2024, registered at P.S. Dehgam, District Gandhinagar,
4. After considering the submissions of learned counsel for the appellant, on 19.01.2026, an interim order was passed, which is reproduced below:

"1. Issue notice, returnable in six weeks.
2. In the meantime, it is provided that in the event the Petitioner is arrested in connection with FIR No. 11216005240881/2024, registered at P.S. Dehgam, District Gandhinagar, he shall be released on a personal bond of Rs. 25,000/- subject to an undertaking that he shall cooperate in the investigation and make himself available for interrogation as and when required by

the investigating agency. He shall also submit an undertaking that he will not threaten the witnesses or tamper the evidence."

5. On service of notice, the State-respondent is represented.

6. Upon consideration of the submissions, we do not find a good reason to vacate the interim order. Consequently, this appeal is disposed of by making the interim order absolute subject to the following two conditions:

A) Within three weeks from today, the appellant shall submit bail bonds to the satisfaction of the Trial Court along with an undertaking that he shall co-operate in the trial/investigation; and

(B) He shall submit an additional undertaking that he will not threaten the witnesses or tamper the evidence.

7. Pending application(s), if any, shall stand disposed of.
