O R D E R

The learned counsel for the petitioners submits that SLP(C) Nos. 106-116/2005 related to the Notification dated 2.5.1980 under Section 4 of the Land Acquisition Act wherein the compensation has been awarded @ Rs.1,70,000/- (Rupees One Lakh and Seventy Thousand) per acre to every one. In the present case, notification under Section 4 is dated 2.9.1981 but the compensation has been awarded @ Rs.1,00,000/- (Rupees One Lakh) per acre for irrigated land and Rs.60,000/- (Rupees Sixty Thousand) per acre for un-irrigated land. The Petitioners are claiming award of compensation @ Rs.1,70,000/- (Rupees One Lakh and Seventy Thousand) per acre. Learned counsel for the petitioners further submits that the dismissal of SLP(C) Nos. 106-116/2005 shall not come in the way of the present petitioners seeking enhancement of compensation.
