This is wife's petition seeking transfer of Matrimonial Petition being Family Suit No. 965 of 2011, Dinesh Kumar Shankar Lal Vanzara vs. Meenaben @ Lilaben Dinesh Vanzara, pending in the Family Court No. 4, Ahmedabad, Gujarat to the court of competent jurisdiction at Nibahera, District Chittorgarh, Rajasthan.
