We are happy that with the efforts of learned counsel for the parties, an amicable settlement has been worked out. It is agreed that the respondents shall pay a sum of Rs. 6,00,000/- (Rupees Six Lakhs only) to the appellant. Out of the said sum, a bank draft for Rs.3,25,000/- (Rupees Three Lakhs and Twenty Five Thousand only) is handed over to learned counsel for the appellant in Court today. The balance amount shall be paid within six months. The balance amount shall be deposited with the Trial Court within a period of six months and terms of agreement shall be filed before the Trial Court within the aforesaid period. It goes without saying that the withdrawal of the amount to be deposited shall be permitted without furnishing any security.
