O R D E R

1. Applications seeking exemption from filing a certified copy of the impugned judgment and official translation are allowed.

In the meanwhile, the petitioners shall not be arrested in connection with First Information Report No. 144/2024 dated 03.11.2024 registered with Police Station - Ghorawal, District - Sonbhadra, Uttar Pradesh, for the offences punishable under Sections 85 and 118(1) of the Bharatiya Nyaya Sanhita, 2023, and Sections 3 and 4 of the Dowry Prohibition Act, 1961, subject to their joining and cooperating with the investigation in relation thereto.
