1. The petitioner's grievance in the instant contempt petition is that the enhanced land acquisition compensation has not been paid in terms of the order dated 14.05.2025 passed by this Court in C.A. No.6836/2025.

2. In our considered opinion, the petitioner should approach the Reference Court, where the respondents were expected to deposit the enhanced amount of compensation as per the time-bound direction given by this Court. If the respondents have not deposited the same, we direct the Reference Court to take lawful action to ensure that the enhanced amount of compensation is paid to the petitioner

and other similarly placed affected landowners.

3. The Contempt Petition is, accordingly, disposed of.
