The matter above mentioned was mentioned before the Hon'ble Court on 06.05.2010, when the Court was pleased to pass the following Order:

“Taken on board.

Issue notice returnable on 14th July, 2010.

However, the State of Kerala and Karnataka shall explore the possibility to work out the modalities of transporting goods vehicles by means of some convoy system during the night time.

Post along with SLP(C) D. No. 14714/2010.”

Accordingly, show cause notice was issued to all the respondents on 16.06.2010 by Regd. A.D. Post. Respondent Nos. 1, 2 to 5 and 7 are represented by Mr. E.C. Mr. Subhash Chandra, Advocate has accepted notice on behalf of Respondent No. 8 but has not filed vakalatnama/appearance, till date. Counter Affidavit has also been filed on behalf of

Respondent Nos. 1, 2 to 5 and 14, and the same has been included in the Paper Books.
