O R D E R

The present petition under Section 406 of the Code of Criminal Procedure (CrPC) has been filed by the petitioner, seeking transfer of Criminal Case instituted against her by the first respondent from Jaipur to Agra.

Counsel for the parties state that a settlement has been arrived at between the parties and a sum of Rs.2 lakhs has been paid in terms thereof (copy of which has been placed on record) and the balance amount of Rs.2.5 lakhs shall be paid in the Court.

In this view of the matter, counsel for the petitioner seeks permission to withdraw this petition for transfer of Criminal Case No.325/2000 [State vs. Gargi Gupta & Anr.] from the Court of Addl. Civil

Judge (Lower Division) and Judicial Magistrate No.9, Jaipur to Agra with liberty to move the High Court of Rajasthan to record the settlement and pass an appropriate order. Counsel appearing for the parties have stated that they shall cooperate in the matter.

Accordingly, the transfer petition stands dismissed as withdrawn.
