1. This petition has been filed on behalf of the wife for transfer of HMA Petition No.428 of 2009, (Mr. Sachin Verma Vs. Mrs. Rachna Verma) pending before Shri Virendra Bhatt, Addl.District Judge, Room No.113, Delhi, to the Principal Judge, Family Court, Lucknow.

2. Having heard learned counsel for the respective parties and having perused the transfer petition and the grounds set out therein, we are satisfied that the transfer petition should be allowed.
