It is submitted that an application for exemption from surrendering (Criminal Misc. Petition No. 3713 of 2013) in the matter above mentioned was listed before the Hon'ble Judge in Chamber on 1st March, 2013 when His Lordship was pleased to pass the following order:

"Prayer for exemption from surrender is declined.

Six weeks' time is granted to the petitioner to surrender and furnish the requisite proof thereof."

Pursuant to the order quoted above, Counsel for the Petitioner has on 18th April, 2013 filed proof of surrender in vernacular language. Counsel was requested to file translated copy

proof of surrender despite this Registry's letter dated 25th April, 2013 and subsequent reminder dated 15th May, 2013. The matter was listed before the Court of Registrar on 23rd July, 2013 and lastly on 8th August, 2013 when the following order was passed :

"Ld.counsel for the petitioner is directed to produce the translated copy of the proof of surrender within four weeks as a last chance. It is submitted that the complainant has filed an application to get himself impleaded as party respondent. Office is directed to verify and process.

List the matter on 30.09.2013."

Counsel for the Petitioner has on 4th September, 2013 field translated copy of Order dated 8th April, 2013 passed by Chief Judicial Magistrate as a proof of surrender with application for exemption from filing official translation.(Copy enclosed)

It is submitted that Mr. S.R. Setia, Advocate has filed an application for impleadment on behalf of the Complainant as a party Respondent. The application has been registered as Criminal Misc. Petition No. 11498 of 2013. Paper book containing the application is circulated herewith for kind perusal of the Hon'ble Court.

The application above-mentioned is listed before the Hon'ble Court with this office report.
