UPON hearing the counsel the Court made the following  
O R D E R

1. The petitioner is in jail with effect from 03.08.2025, for allegedly being involved for offence

punishable under Sections 303(2), 318(2), 318(4), 319(2), 336(2), 336(3), 340(2),3(5), 61(2) of the Bharatiya Nyaya Sanhita, 2023 and Sections 66(c), 66(d) of the Information Technology Act, 2000, bearing FIR No. 25 of 2025 registered at Police Station Sheikhpura, Cyber, District Sheikhpura.

2. Indisputably, co-accused namely Ankush Kumar, Rajeev Ranjan, Nitish Kumar and Kunal Kumar have been released on bail by the High Court and the Sessions Court, as the case may be.

3. Considering the above, we deem it appropriate to release the petitioner on bail on such terms and conditions as may be imposed by the Trial Court, subject to the condition that the petitioner shall continue to co-operate with the trial.

4. Accordingly, the Special Leave Petition stands disposed of.

5. Pending applications(s), if any, shall also stand disposed of.
