UPON hearing the counsel the Court made the following
O R D E R

1. Issue notice to the respondents.
2. Mr. Ashutosh Nagar, learned counsel appearing for the respondent/caveator(s) accepts notice.
3. Since the petitioner herein had not yet filed its objections to the application(s) seeking interim reliefs in appeal filed by the respondent(s) herein

against the order of the learned Single Judge dated 01.08.2025, we find that this is a fit case where the impugned order ought to be stayed.

4. However, the petitioner herein is directed to file its objections on or before 09.02.2026.
5. It is needless to observe that on such objections being filed, the Division Bench of the High Court shall rehear the application seeking interim stay of the order of the learned Single Judge afresh or alternatively, dispose of the appeal itself.
6. The pendency of the matter before this Court shall not come in the way of the Division Bench of the High Court hearing the application for interim stay afresh or disposing of the appeal out of which the impugned order arises.
